## Types of Graves

### Ash Plot

An ash plot allows for 4 interments overall. A classic headstone and base combination to be placed to a design of your choosing.

Remains interred within ash plot grave are placed below ground.

### Memorial Garden Grave (MGG)

MGGs allow for 2 interments overall. The unit is made from all polished black granite which is included within the purchase price allowing for an inscription of your choice to be added.

Remains are placed and sealed within the MGG unit and a bespoke urn must be used.

### Memorial Garden Sanctum (MGS)

MGSs allow for 2 interments overall. The unit is made from all polished blue pearl granite which is included within the purchase price allowing for an inscription of your choice to be added.

Remains are placed and sealed within the MGS unit and there are no restrictions on the urn that can be used.

### Balustrade Niche

Balustrade Niches are above ground burial chambers designed for cremated remains. Each balustrade can accommodate two interments and have a blank inscription panels already in place for an inscription of your choosing.

A bespoke urn must be used.

Grave rights are issued for a period of 30 years. These are known as the Exclusive Rights. Only the registered grave owner can authorise a burial or the memorialisation of a grave.

These rights can be extended upon request.

## How do I proceed?

Once you have made a decision, simply complete the applicable application form included within this information pack.

## How do I arrange the interment?

Interments are available Monday - Friday between 10am at 3pm.

If you wish to be present it's best to have an idea as to suitable dates you would prefer.

If you don't wish to be present then you just need to let us know.

Once you are ready, contact our main cemetery office and a member of the team will be happy to look after you and explain the process in full.

RCLA23 is situated toward the rear of the cemetery site and is within a Roman Catholic burial area.

Each ash plot can accommodate a maximum of 4 interments overall and there are no restrictions to the urn or caskets that can be used. Remains are buried below ground.

Stone memorials or plaques can be placed to a design of your choosing and are purchased separately.
